3. The rates for each of the above items are to be mentioned per kg for **RICE SEED** and each of the **MANGO STONE** and the tenders are to be **submitted separately in separate cover mentioning the name of the item and the project's name.**
4. An amount of **Rs.12,000/-** only for **Paddy Seeds** and **Rs.3000/-** only for **Mango Stones** being the **Earnest Money** must be accompanied with each of the tenders in the form of DD/Deposit-at-Call in favour of the Joint Director, ICAR, Tripura Centre of any Bank payable at Agartala.
