The successful bidder has to adhere to the Plan & Estimate while minor deviation as may be specified by the undersigned/concerned Scientist I/c. will be allowed subject to approval of the undersigned and further subject to the condition that the total expenditure must remain restricted to the administrative approved costs for each of the above works.
2. On completion of the allotted work, the bill in triplicate with **Measurement Book** duly signed by the Tech. Officer (AAS) and copy of the handing over report may be submitted to the undersigned for arranging payment. The payment will be made from our Complex's H. Qrs., Umiam, Meghalaya against bidder's bills and other related documents.
